<b>Mandy Kirk, OLG Principal</b>	Principal's Report	*Overall things are quiet. OLG had their 1st COVID positive student. 9 students will return from the quarantine this Wednesday. Hamilton County was impressed with how OLG handled the positive test and how quickly families were notified and impacted students quarantined. There were no further positive tests from students so Hamilton County is not linking this case to OLG. The student who did test positive is doing well. *Free lunches are available through December at this time and the government may be looking to extend this program through the entire year. More to come as information becomes available. *61 OLG HOME students returned to the classroom in October, we are expecting more to return in November.
