Registration Deposit

There is an annual, non-refundable registration deposit of \$50 per family. This is applied to your tuition and fees.

The in-parish rates apply for registered parishioners of Assumption, St. Ann, St. Margaret Mary or Little Flower parishes who meet requirements defined for "Active Parishioner." The non-parish rate applies for non-parishioners or those not meeting requirements defined for "Active Parishioner."

Method of payment (OLG uses FACTS Management Co. to process tuition/fees payments)

A tuition and fee payment plan may be selected that best suits your financial needs. This may be paid in annual, semi-annual or monthly installments. Monthly and semi-annual payments must be set up to debit from your bank account.

Pay in full discount

Families who pay tuition and fees in full by July 5, 2021 receive a \$50 discount per student.

Tuition assistance

Active parishioners of Assumption, St. Ann, St. Margaret Mary or Little Flower parishes may apply for tuition assistance from the parish in which they are registered, through FACTS Management. The State verifies family household income and determines the percentage of scholarship awarded to the applicant student. This may result in the family needing to pay the remaining percentage of the tuition, in addition to the fees of \$470.
